- Organization must be registered in Poland.
- For enterprises it is strongly advised to state in the Pre-proposal application form the KRS number of the enterprise and the size of the enterprise (micro/small, medium, large).
- If two Polish participants take part in the project, they must form an internal national consortium to sign the contract with the National Centre for Research and Development (NCBR). The above consortium still counts as two project partners from Poland (it meets the maximum number of participants from the same country, please see call text for details).

Funding quota of Polish participants can be up to 100% for universities or research organizations. In the case of enterprises, funding quota will be decided on a case-by-case basis depending on the size of the company, type of research/development, risk associated with the research activities and commercial perspective of exploitation, under the Regulation of the Minister of Science and Higher Education of 19 August 2020 on criteria and rules on granting state aid by the National Centre for Research and Development, published in Journal of Laws item 1456, 2020.
